Minutes of Meeting of Purchase Committee of JREDA held on 11.05.2013 at JREDA Office for Evaluation of Eligibility Bid against NIT NO: JREDA/SPP/ PANCHAYAT&BLOCK/02/2012-13 for Design, Manufacture, Testing, Supply, Installation & Commissioning of 1.0 kWp & 2.0 kWp Capacity SPV Power Plants in Panchayat & Block offices of all districts of Jharkhand on Turnkey basis including 5 years CMC on the complete system.

Purchase Committee meeting of JREDA held on 11.05.2013 at JREDA Office for evaluation of eligibility bid against NIT NO: JREDA/SPP/ PANCHAYAT&BLOCK/02/2012-13. Comparative Statement prepared by Tender Committee of JREDA based on documents submitted in eligibility bid by all 20 (Twenty) bidders on 30.03.2013 and its recommendations were perused by Committee members.

On the basis documents submitted in eligibility bid by all 20 (Twenty) bidders on 30.03.2013 and Comparative Statement of Eligibility bid Part-I prepared by Tender Committee of JREDA views of Purchase Committee of JREDA on their eligibility bid are as follows:

- 1. M/s Statecon Power Controls Ltd: The bidder has submitted Bank Guarantee for a capacity of 700 kWp, while offer has been made for 750 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid and its evaluation only for 700 kWp.
- 2. M/s Multi Service Inc.: M/s Multi Service Inc. is a Jharkhand's registered MSME bidder & Manufacturer of Electronics item. He has submitted the bid through a consortium of three parties. The other consortium partners are the business firm located outside Jharkhand. The bidder has submitted the experience certificate of successful execution of SPV Systems of required capacity of M/s Gitanjali Solar Enterprises, Kolkata as a Consortium partner. The bidder has not submitted the tender document fee and earnest money claiming that it is a bid by the Jharkhand's MSME. The committee has perused the document of the this tender file and has observed that during pre-bid conference meeting held on 13.03.2013 the proprietor of M/s Multi Service Shri Kamal Chaudhary has raised this issue and it was clarified to him that any Jharkhand's MSME forming a consortium with non MSME will not be entitled to the benefit as available under Jharkhand Industrial Policy. This is a case of MSME of Jharkhand with consortium partner with none MSME claiming the benefit of MSME of Jharkhand hence not eligible. This decision has been also confirmed by the JREDA Chairman. Therefore in this background the committee is also of the view that the bidder consortium can not be treated as Jharkhand's MSME and accordingly they are not entitled for the benefit as provided under the Jharkhand Industrial Policy 2012 and accordingly the bidder should have submitted the tender fee and earnest money which has not been done by them. Accordingly committee concludes that this bidder is not eligible for opening of Technical Bid.
- **3.** M/s Bhattacharya Engineering: The bidder has submitted Bank Guarantee for a capacity of 250 kWp and offer has also been made for 250 kWp. On perusal of the report of tender committee and

the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.

- 4. M/s Pace Power System Pvt. Ltd: The bidder has submitted Bank Guarantee for a capacity of 1000 kWp and offer has also been made for 1000 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is observed that bidder has given the past performance statement on page no. 22 of its bid. This statement enlists 5 projects. The page no. 23 to 102 of the bid has been submitted by the bidder in support of claim of experience. The committee observed that none of these documents indicates the satisfactory execution of the said projects. The document as at page no. 49 to 53 indicates the measurement or bill payment of some work of the bidder but on the basis of these documents it can not be concluded that whether such projects have been completed satisfactory or not and what is the capacity of these project. As per the tender conditions the bidder is essentially required to submit the certificate indicating the successful execution of the project as at Annexure-2 and bidder has not submitted copy of any successful execution certificate. Accordingly committee concludes that this bidder is not eligible for opening of Technical Bid.
- 5. M/s Sungrace Energy Solutions Pvt. Ltd.: The bidder has submitted Bank Guarantee for a capacity of 500 kWp and offer has also been made for 500 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 6. M/s Exicom Tele Systems Ltd.: The bidder has submitted Bank Guarantee for a capacity of 1000 kWp and offer has also been made for 1000 kWp. Further Committee observed that the bidder has not given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total 194 nos. of pages were found, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 7. M/s Sigma Steel & Engineers. Pvt.: The bidder has submitted Bank Guarantee for a capacity of 200 kWp and offer has also been made for 200 kWp. Further Committee observed that the bidder has not submitted their offer in spiral/ hard bound, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 8. M/s Annapurna Export: The bidder has submitted Bank Guarantee for a capacity of 240 kWp and offer has also been made for 240 kWp. Further Committee observed that the bidder has not given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total 155 nos. of pages were found, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 9. M/s Pearl Enterprises: The bidder has submitted Demand Draft for earnest money for a capacity of 500 kWp and offer has also been made for 500 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is observed that bidder has given the past performance statement on page no. 52 of its bid. This statement enlists 14 projects. The page no. 34 to 51 of the bid has been submitted by the bidder in support of claim of experience. The committee observed that the page no. 35 (same copy at page 46), 37 (same copy at page 50), 38 (same copy at page 49), 39 (same copy at page 48) and 40 indicates the satisfactory execution of the said projects totaling up to 22 kWp only against the claim of 132 kWp. Further Committee observed the bidder has not given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total

- 222 nos. of pages were found, which is recorded in videography. The rest documents are only of the supply order placed by the different offices for supply and installation. As per the tender conditions the bidder is essentially required to submit the certificate indicating the successful execution of the project as at Annexure-2 and bidder has not submitted copy of successful execution certificate for 50 kWp which is essentially required to make it eligible for the minimum lot size of 200 kWp. Accordingly committee concludes that this bidder is **not eligible** for opening of Technical Bid.
- 10. M/s Millennium Synergy Pvt. Ltd.: The bidder on the basis of being Jharkhand's MSME has offered for 1000 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is observed that it is fulfilling all the eligible criteria. However, the letter no. 180 dt. 04.02.2013 issued by the DIC, Ranchi to Energy Department was brought to the notice of committee by JREDA office. The committee observed that this letter states that "दिनांक 10.09.2007 का स्थलीय निरीक्षण दिनांक 02.02.2013 के कम में पाया गया कि इकाई में किसी भी तरह का उत्पादन का कार्य नहीं चल रहा था एवं उत्पादन हेतु आवश्यक प्लाट मशीनरी एवं उपकरण नहीं पाया गया।". On perusal of this letter the committee concludes that the latest position with respect to the proposed action of the DIC, Ranchi about the cancellation of acknowledgement entrepreneur memorandum no. of the bidder as MSME should be ascertained urgently. For the time being it was concluded and recommended that the bidder's offer may be considered eligible for opening of Technical Bid.
- 11. M/s Waaree Energies Pvt. Ltd.: The bidder has submitted Bank Guarantee for a capacity of 500 kWp and offer has also been made for 500 kWp. Further Committee observed that the bidder has neither submitted their offer in spiral/ hard bound nor given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total 232 nos. of pages were found, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 12. M/s Wilson Printcity Pvt. Ltd: The bidder has submitted Bank Guarantee for a capacity of 500 kWp and offer has also been made for 500 kWp. Quoted quantity by bidder is 500 kWp but on the basis of successful completion certificate M/s Wilson Printcity Pvt. Ltd is eligible only for 250 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid and its evaluation only for 250 kWp.
- 13. M/s Visa Powertech: M/s Visa Powertech has neither submitted supporting documents nor Bid Document Fee & EMD as per NIT. Accordingly committee concludes that this bidder is **not eligible** for opening of Technical Bid.
- 14. M/s Minda Industries Ltd.: The bidder has submitted Bank Guarantee for a capacity of 1000 kWp and offer has also been made for 1000 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 15. M/s S.G. Enterprises: The bidder has submitted their offer for 1000 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 16. M/s Abhishek Solar Industries Pvt. Ltd.: The bidder has submitted their offer for 1000 kWp. The committee observed that some papers of bid documents are not signed. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.

- 17. M/s Solar Industries: As per NIT Net worth should be at least Rs.24.00 Lakh for MSME of Jharkhand but Net Worth of M/s Solar Industries is 10.19 Lakh only. However, he has submitted Credit Information Report/ Solvency Report of Bank dated 25.03.2013 for their credit limit of Rs. 32.00 Lakh Cash & Rs. 40.00 Lakh BG which may not be considered as per NIT terms & conditions. It was informed to the committee that in view of the request of bidder matter of consideration of Solvency Certificate in place of Net worth was placed and discussed in the JREDA Management Committee meeting held on 08.05.2013 but it was not accepted by the Management Committee. Accordingly committee concludes that this bidder is not eligible for opening of Technical Bid.
- 18. M/s Kotak Urja (P) Ltd.: The bidder has submitted Bank Guarantee for a capacity of 500 kWp and offer has also been made for 500 kWp. Further Committee observed that the bidder has not given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total 74 nos. of pages were found, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 19. M/s Tata Power Solar System Ltd.: The bidder has submitted Bank Guarantee for a capacity of 1000 kWp and offer has also been made for 1000 kWp. On perusal of the report of tender committee and the documents submitted by the bidder, it is recommended that the bidder's offer is eligible for opening of Technical Bid.
- 20. M/s Power One Micro Systems (P) Ltd.: Original DD of tender fee and BG of EMD were not found in the Eligibility bid. However, it has been undertaken by M/s Power-One Micro System that due to human error original DD and BG has been placed with Technical Bid evaluation. The bidder has offered bid for implementation of 200 kWp. Further Committee observed that the bidder has neither signed all the paper nor given the serial no. of papers. There paper were serially numbered on the eve of Eligibility bid opening & total 98 nos. of pages were found, which is recorded in videography. It is not the minimum eligibility criteria, therefore Committee decided to consider their bid offer. Accordingly committee concludes and recommended that the bidder's offer may be considered eligible for opening of Technical Bid. However, technical bid will be evaluated only subject to availability of original DD of Tender Fee & BG along with Technical Bid.

Purchase Committee recommends for opening of Technical Bid of successful bidder in Eligibility Bid as indicated above against NIT NO: JREDA/SPP/ PANCHAYAT&BLOCK/02/2012-13.
