Purchase Committee meeting of JREDA held on 13.06.2013 at JREDA Office for evaluation of Technical bid against NIT NO: JREDA/SPP/ PANCHAYAT&BLOCK/02/2012-13. Comparative Statement prepared by Tender Committee of JREDA and its recommendations were perused by Committee members.

On the basis documents submitted by bidders and Comparative Statement of Technical bid Part-II prepared by Tender Committee of JREDA views of Purchase Committee of JREDA on their Technical bid are as follows:

- 1. M/s Statecon Power Controls Ltd.: The bidder is an ISO 9001certified company (10 Marks) and MNRE Channel Partner (10 Marks). The bidder has submitted annual turnover of Rs.72.59 Crore (15 Marks), cumulative experience along with timely completion certificates for above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems is up to 3 years (5 Marks). Regarding the technical manpower qualification, this firm has submitted the photocopy of Form 16 of the Engineers / Diploma Holders along with their PAN and TIN No. at page no. 126 to 215 of technical bid (20 Marks). The bidder is a general firm. Therefore, based on the documents submitted the bidder has got technical score of 90 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.
- 2. M/s Bhattacharya Engineering: The bidder is an ISO 9001certified company (10 Marks). The bidder has submitted annual turnover of Rs. 5.34 Crore (10 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems more than 5 years (15 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only salary statement of them has been submitted on page 126 to 215 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a general firm. Based on the documents submitted the bidder has got technical score of 65 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.
- 3. M/s Sungrace Energy Solutions Pvt. Ltd.: The bidder is an ISO 9001certified company (10 Marks) and MNRE Channel Partner (10 Marks). The bidder has submitted annual turnover of Rs. 6.65 Crore (15 Marks), cumulative experience along with timely completion certificates of above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems more than 5 years (15 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only salary statement of them has been submitted on page 32 to 51 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a general firm. Based on the documents submitted the bidder has got technical score of 80 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid. Pages of bid document not serially numbered.
- 4. M/s Exicom Tele Systems Ltd.: The bidder is an ISO 9001certified company (10 Marks) and MNRE Channel Partner (10 Marks). The bidder has submitted annual turnover of Rs. 73.21 Crore (15 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems up to 3 years (5 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only salary statement of them has been submitted on

page 56 to 86 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a general firm. Based on the documents submitted the bidder has got technical score of 70 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.

- 5. M/s Sigma Steel & Engineers. Pvt.: The bidder is an ISO 9001certified company (10 Marks). The bidder has submitted annual turnover of Rs. 5.86 Crore (10 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems more than 3 years (10 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only list of them has been submitted on page 4 to 11 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a general firm. Based on the documents submitted the bidder has got technical score of 60 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.
- 6. M/s Annapurna Export: The bidder is an ISO 9001certified firm (10 Marks). The bidder has submitted annual turnover of Rs. 1.76 Crore (10 Marks), cumulative experience along with timely completion of 62 kWp of SPV Systems (10 & 3.1 Marks), no. of years of experience in SPV Systems up to 3 years (5 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only list of them has been submitted on page 60 to 62 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidding firm is M/s Annapurna Export, Burdwan. The bidder has a unit in Dhanbad as Jharkhand MSME. The bidder has submitted tender document fee & EMD as a general bidder. Since the bidding firm has submitted all document of Turnover, Net worth and work experience of M/s Annapurna Export, Burdwan not M/s Annapurna Export, Dhanbad. Hence bidder may be treated as general bidder for which qualifying marks is 60. Based on the documents submitted the bidder has got technical score of 38.10 marks, hence it is recommended that the bidder is not qualified for opening of Price Bid.
- M/s Millennium Synergy Pvt. Ltd.: The bidder is an ISO 9001certified company (10 Marks), MSME of Jharkhand (10 Marks). The bidder in its certificate for annual turnover has submitted annual turnover of Rs. 5.50 Crore of M/s Millennium Synergy Pvt. Ltd, Ashok Nagar, Ranchi. Further, on perusal of the balance sheets which are attached with this turnover certificate, it is observed that all the turnover figures are of M/s Millennium Synergy Pvt. Ltd., Bangalore. This indicates that the bidder has not submitted the copies of the balance sheets / documents of the applicant/ bidder firm i.e. M/s Millennium Synergy Pvt. Ltd., Ashok Nagar, Ranchi, which is an MSME unit of Jharkhand. Further, it has been observed that this bidder has not submitted the bid fee and earnest money on the pretext of being a MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and net worth as that of M/s Millennium Synergy Pvt. Ltd., Bangalore, which is not the bidder firm. The committee also observed that although the bidder has submitted the balance sheet in the eligibility documents also but it was attached at the item no. 3 i.e. to indicate only the functionality of the firm. Further, at the turnover and net worth criteria items in the eligibility documents only the certificate issued by the CA for turnover and net worth were submitted without any supporting documents. Therefore this aspect could not be ascertained at eligibility evaluation. During the eligibility evaluation the matter was deferred in the background of industry department observations of non-existence of any equipment for manufacturing at the address given by the bidder. Therefore, in this way it is now concluded by the committee that bidder has not submitted the desired documents to substantiate its eligibility with respect to turnover and net worth. Therefore it is recommended that the bidder is neither eligible for technical evaluation no qualified for opening of Price Bid.
- 8. M/s Waaree Energies Pvt. Ltd.: The bidder is an ISO 9001certified company (10 Marks) and MNRE Channel Partner (10 Marks). The bidder has submitted annual turnover of Rs. 124.23 Crore (15 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems up to 3 years (5 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only salary statement of them has been submitted on page 224 to 248 of technical bid. Thus no marks have been considered for technical manpower qualification.

The bidder has submitted annual turnover of Rs. 872.35 Crore (15 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems up to 3 years (5 Marks). The copies of Form-16 for the Engineer/Diploma Holder/Technician have been submitted which do not have the PAN & TIN No. as on page 106 to 171 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a general firm. Based on the documents submitted the bidder has got technical score of 70 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.
- 11. M/s S.G. Enterprises: The bidder is an ISO 9001certified firm (10 Marks), MSME of Jharkhand (10 Marks). The bidder has submitted annual turnover of Rs. 7.30 Crore (15 Marks), cumulative experience along with timely completion above 200kWp of SPV Systems (20 & 10 Marks), no. of years of experience in SPV Systems more than 5 years (15 Marks). Although, the bidder has submitted only the performance certificate of JREDA and no supply order has been enclosed but the committee decided to accept it in view of the background that since this performance certificate have been issued by the JREDA itself and the supply order are available in this office, therefore, experience may be accepted. The copies of Form-16 for the Engineer/Diploma Holder/Technician have not been submitted and rather only salary statement of them has been submitted on page 13 to 19 of technical bid. Thus no marks have been considered for technical manpower qualification. The bidder is a Jharkhand MSME. Based on the documents submitted the bidder has got technical score of 80 marks, hence it is recommended that the bidder is technically qualified for opening of Price Bid.
- 12. M/s Abhishek Solar Industries Pvt. Ltd.: The bidder is an ISO 9001certified company (10 Marks) and MSME of Jharkhand (10 Marks).
