### 1. Eligibility and Qualification Criteria

The bidder shall meet the following requirements:

- (i) The bidder
  - ▶ should be a reputed supplier of SHLS and who manufactures/assembles at least one or more major sub-systems (viz. PV modules or Storage Battery or Electronics) used in the Solar Home Lighting System.
  - ▶ should have adequate facilities for testing of the Solar Home Lighting System.





To meet the requirement under (i), the bidder shall furnish

- i. Registration certificate clearly indicating that they are supplier / manufacturer / assembler of solar home lighting system including PV module / storage batteries / electronics as applicable.
- ii. List of manufacturing and testing facilities along with their photographs.
- (ii) The bidder must be in possession of valid test report for the SHLS of **Model 2** either from Solar Energy Centre (SEC), Gurgaon; or Electronics Regional Test Laboratory (East) (ERTL), Kolkata; or Central Power Research Institute (CPRI), Thiruvanantapuram; or Energy Conservation and Development Division (ECDD), Bangalore; or Electronics Test & Development center (ETDC), Bangalore The corresponding test reports clearly marking the validity shall be submitted along with bid. The test certificate issued on or after 1<sup>st</sup> April 2005 will be eligible for supply for 2006-07 programme subject to meeting eligibility criterion for manufacturer as per Sl. No. 1(i). The SHLS of **Model 2** tested on or after 1<sup>st</sup> April 2005 must have the specification as per Section 2A (for CFL based SHLS).

To meet the requirement under (ii), the bidder shall submit the valid test certificate issued on or after 1<sup>st</sup> April 2005 from any aforesaid authorized test centres. Test Certificate issued before 1<sup>st</sup> April 2005 will not be considered.

(iii) The bidder should have supplied photovoltaic based solar systems of the value of at least Rupees 2 crore (Rupees 1 crore for any SSI units registered with Govt of Jharkhand) to any State Nodal Agencies during any one of the past three financial years and supplies against such work order should have performed satisfactorily as certified by the concerned State Nodal Agencies.

(This clause will not be applicable for SSI units registered with Govt of Jharkhand as well as with NSIC.)

To meet the requirements under (iii), the bidder shall submit (a) attested photocopies of purchase orders / contracts and (b) the certificate from the concerned State Nodal Agencies for the completion of the work satisfactorily. Non-submission of above document may result in rejection of bid.

- (iv) Bidder shall furnish up-to-date Sales Tax (S.T) / Value Added Tax (VAT) clearance certificate, EPF No, and Sale Tax /Value Added Tax registration no.
- (v) The bidder should have supplied a minimum lot of 100 nos of CFL based SHLS and which should be in satisfactory working condition for a minimum period of 1 year as on the date of submission of bid.

To meet the requirement under (v) above the Bidder shall submit attested photo copies of certificates from the respective Clients.

2. For availing any concession in cost of bid document and / or EMD, the bidder shall furnish attested copies of valid SSI registration certificate issued by Govt. of Jharkhand and/ or from NSIC clearly indicating validity &monetary limit, as applicable.





- 3. Bidder may submit their Offer for minimum lot size defined or additional quantities, and EMD for each additional quantity shall be enhanced as mentioned in TABLE 1.
- 4. Cost of the bid documents (non-refundable) shall be deposited in the form of Demand Draft drawn in favour of Director, JHARKHAND RENEWABLE ENERGY DEVELOPMENT AGENCY on any Indian Nationalised Bank / Scheduled Bank, payable at RANCHI, India. Bidder will purchase bid document from the office of Director, JHARKHAND RENEWABLE ENERGY DEVELOPMENT AGENCY, Plot No. 328/B, Road No. 4, Ashok Nagar, Ranchi 834002 after submission of cost of bid document. Prospective bidders can also download complete bid document from the web site of JREDA (address indicated above) and submit their bid alongwith cost of Bid document (in Part I envelope) in the manner described herein above.
- 5. Bid documents including Terms & Conditions and detailed specification of work shall be available on submission of demand draft from the Office of the Director of JHARKHAND RENEWABLE ENERGY DEVELOPMENT AGENCY during the time and period as mentioned in TABLE 1 hereinabove.
- 6. All bids will be received in duly Sealed Cover within the due date and time. Bids received after the due date and time are liable for outright rejection.
- 7. Details about date and time of issue of bid documents, submission of bid, opening of bid, date, time, place of submission etc are given in Table 1.
- 8. If it happens to be holiday on the date of submission / opening of bids then same shall be submitted/ opened on next working day at the same time & at the same venue.
- 9. No postal transaction shall be entertained for obtaining of Bid Documents.
- 10. Issuance of bid documents shall not construe that the bidders would be automatically considered qualified.
- 11. EMD shall be submitted in the form of Demand Draft from any Indian Nationalised Bank/ Scheduled Bank payable at Ranchi or in the form of Bank Guarantee from any Indian Nationalised Bank along with bid.
- 12. Bid documents are not transferable.
- 13. JREDA reserve absolute rights to distribute the total quantities to any number of bidders, in the way deems fit.
- 14. JREDA reserves the right to amend the scope of work, accept or reject any or all the offers/ bids, in part or in full or cancel/withdraw the invitation for bids without assigning any reasons whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 15. JREDA reserves the right to postpone the date of receipt and opening of the bids or cancel the bid without bearing any liability, whatsoever, consequent upon such decision.
- 16. Bidder shall submit his Permanent Account Number (PAN) copy and recent passport photographs of Managing Director and other two Directors or CEO of the company with Name and Address or photocopy of the passport.
- 17. The bidder shall submit the GPS Co-ordinate (Longitude & Latitude) and digital photograph of their registered office and factory campus showing their board etc.





- 18. Purchase from the small-scale Industrial units located within the State of Jharkhand shall be as per Industrial Policy of Jharkhand 2001 as detailed in this document.
- 19. If at any time any of the documents/ information submitted by the bidder is found to be incorrect, false or untruthful, the bid and/ or the resultant order may be summarily rejected/ cancelled at the risk of the bidder.

### <u>SECTION – 1</u> GENERAL TERMS & CONDITIONS

#### 1.0 INTRODUCTION

- 1.1 The instruction/information contained in the Bid documents are for guidance and compliance of the intending Bidder. Bidder is advised to obtain, in writing, clarifications from the Jharkhand Renewable Development Agency (JREDA), if any, prior to submission of their Bid, failing which it will be deemed that the stipulation made in the Bid documents have been read, understood and are acceptable to the Bidder.
- 1.2 Bidder shall bear all costs associated with preparation and submission of the Bid, journeys undertaken by them, and subsequent Bidding process till award of the order to successful Bidder and the JREDA shall, in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the Bidding process.

#### 2.0 BID DOCUMENTS

2.1 Bid documents shall comprise of NIB, Section-1, 2A, 2B, & Proforma-I to X (A, B & C). In addition, any other document / instruction / amendments / revisions issued by the JREDA to the Bidder till due date of submission of the offers, shall also be deemed to be integral part of the order. Failure to furnish all the information required by the bidding document in every respect will be at bidder risk

#### 3.0 COST OF BID

- 3.1 Non-refundable cost of Bid document shall be submitted by the Bidder during purchasing of bid document, in form of a Demand Draft from any Indian Nationalised Bank / Schedule Bank, drawn in favour of Director, JREDA, Ranchi. The cost of BID DOCUMENT shall be **Rs.** 10,000/- (Ten Thousands Rupees only)
  - ▶ for those SSI units, which are registered with Govt. of Jharkhand Rs. 5,000/-
  - ▶ for SSI units registered with Govt. of Jharkhand as well as with NSIC Nil Bidders downloading the Bid document from JREDA web site, shall submit the cost of bid document at the time of submission of their bid inside Part I envelope, i.e., envelope for earnest money deposit.

#### 4.0 SCOPE OF WORK

#### The Scope of work for SHLS includes:

Manufacture/assemble, shop testing, packing & forwarding, transportation, transit insurance, supply, installation, testing & commissioning of CFL as well as LED based SHLS system complete in all respects on turnkey basis along with one set of operation instruction cum maintenance manual (both English and Hindi) for each set and delivery on FOR destination/site (door delivery) basis across the State of Jharkhand including, demonstration of performance and training at all sites located within the state of Jharkhand as per direction of JREDA. List of villages will be given before start of dispatch by JREDA.





#### 5.0 TECHNICAL SPECIFICATION

The general technical specification of SHLS are enclosed at Section -2A & Section -2B. SHLS offered by the bidder should conform to the Ministry of New and Renewable Energy (MNRE) specification.

The bidder shall submit a "Compliance Certificate for meeting Technical Specifications" along with the Part-II: Technical & Commercial Part, as per Proforma – III for qualification conditions. The bidder shall submit the detailed technical specifications of the SHLS offered to be supplied.

#### 6.0 TEST CERTIFICATE

It is mandatory for the bidders to have test certificate issued by the Solar Energy Centre (SEC), Gwalpahari – Gurgaon, Haryana; or Electronics Regional Test Laboratory (East) (ERTL) Bidhan Nagar, Kolkata; or Central Power Research Institute (CPRI), Thiruvananthpuram; Energy Conservation and Development Division (ECDD), Bangalore; or Electronics Test & Development center (ETDC), Bangalore that SHLS conform to specification of MNRE, Govt of India for the year 2006-07. Test Certificates issued on or after 1<sup>st</sup> April, 2005 would be considered valid only if it is as per latest MNRE specification on SHLS **Model 2**, this is detailed in technical specifications Section-2A for CFL based SHLS and Section-2B for LED based SHLS. The test issued prior to 1<sup>st</sup> April 2005 is not valid. Bid received without test certificate with Technical & Commercial Part: Part–II will be rejected outright and no correspondence will be entertained in this regard.

The test reports shall be furnished for specific make/manufacturer, type/model number and capacity of a particular SHLS. The bidders are not allowed to change make / model of any components / items at the time of supply. The test report issued by SEC/ERTL/CPRI/ECDD/ETDC test centers shall be considered valid only for a specific make/ model mentioned in that test report. No test report shall be considered valid wherein more than one make / model is specified for the SHLS components in a single test report.

#### 7.0 QUANTITY OF SUPPLY

The requirement given in Table–1 of Notice Inviting Bid, the Bill of Quantity indicated is tentative and is subject to increase or decrease depending upon the actual requirement at the time of placing order and resource available.

Bidder may submit their Offer for minimum lot size and additional quantities as defined, and EMD for each additional quantity shall be enhanced as mentioned in TABLE - 1. In case any bidder offers less than the minimum lot size their offer will be rejected.

#### 8.0 MINIMUM ELIGIBILITY AND QUALIFICATION CRITERIA

- 8.1 This has been detailed in Notice Inviting Bid.
- 8.2 Bid(s) of bidders who do not submit valid test reports for the system in terms of stipulations of as given above shall be rejected as being non-responsive.
- 8.3 The bidder shall submit a letter in confirmation of meeting the Minimum Eligibility Conditions and qualification conditions as per Proforma II given in the bid document.





8.4 The bidder shall submit declaration that they have never be de-listed or banned at any time in the past by any State Nodal Agency, State Govt, Public Sector undertaking or Central Govt. On failure to submit the same, JREDA shall have the discretion to reject the bid.

#### 9.0 SUBMISSION OF BID

- 9.1 The Bid shall be prepared and submitted by typing or printing in English with indelible black ink on white paper in consecutively numbered pages, each page signed alongwith duly filled in format(s) as per bid document. The bidding document shall comprise the documents as stated in the bid and to specify/confirm the same in the check-list enclose in the bid document.
- 9.2 All original and amendments / revisions to Bid Documents, including minutes of meeting, issued by the JREDA, if any, shall be signed and submitted along with the Bid. The Bid submitted by the Bidder shall take into account all such amendments/revisions and minutes of meeting, if any.
- 9.3 Bidders are advised to submit their Bids strictly based on the specification, terms and conditions contained in the Bid documents and subsequent revisions / amendments, if any, the same shall also be considered as an integral part of the Bid'.

#### 10.0 Mode of Submission

- 10.1 Sealed bid should be submitted in three separate parts, Part-I, Part-II & Part-III. Each envelope should be super-scribed on top left side indicating clearly bid notice no., SPV System nomenclature/type & model, due date of opening as may be, details of EMD, Part (I/II/III), name & address of the bidder, fax & telephone of contact person etc. as required. These envelopes should again be sealed in a covering envelope, along with forwarding letter, super-scribed on top with "Offer for supply of SPV system SHLS", NIB No., Part-I, Part-II, Price Part (Part-III), Bid Paper Purchase Receipt No., Date of opening of Part I & II Name & address of bidder, etc. Details of Part-I, II & III given below;
  - a) Part-I Earnest Money: To submit in original only.
  - b) Part-II Technical & commercial: To submit in original plus two Copies & one soft copy in the form of Compact Disk (CD)
  - c) Part-III Price: To submit in original plus one copy

Bid shall be submitted under a covering letter indicating clearly the summary of Bid Chapters with Proforma and subsequent revisions / amendments, if any, schedules of the complete Bid.

#### 10.1.1 Part-I: EARNEST MONEY

This cover should be sealed and super-scribed "PART – I; Earnest Money". The original EMD and/or registration certificate as applicable, along with a covering letter indicating the quoted quantity, shall be submitted as per Clause No. 11. For availing concession/exemption in EMD by SSI registered in Jharkhand, bidder should submit relevant SSI registration certificate from Govt of Jharkhand and/or from NSIC as applicable. For Bidders not submitting earnest money or SSI





Unit registered in Jharkhand not submitting relevant SSI registration certificate from Govt of Jharkhand and/or from NSIC shall be liable for outright rejection.

EMD shall be submitted in the form of Demand Draft from any Indian Nationalised Bank/ Scheduled Bank or Bank Guarantee (as per proforma enclosed at Proforma-X A) from any Indian Nationalised along with bid.

This part shall also contain Cost of Bid Document, as applicable for those bidders, who have downloaded the Bid Document from JREDA web site.

#### 10.1.2 Part-II: TECHNICAL & COMMERCIAL

This cover should be sealed and super-scribed "PART – II; TECHNICAL AND COMMERCIAL BID" followed by the title of work and Enquiry reference.

'Technical' and 'Commercial' Part of the offer shall be submitted in original plus two copies, each copy shall contain 1 (one) set of the following:

- a) General terms and Conditions of Contract, Proforma, Un-priced Price Schedule, Technical specification and any additional instruction or documents issued shall be duly signed and stamped on each page as a token of having been read, understood and accepted all the terms and conditions mentioned therein. A CD shall be submitted for this part.

c) Please note that this is a zero deviation tender. Bidders are advised to strictly confirm compliance to bid conditions and not to stipulate any deviation / conditions in their offer. Subsequent to bid submission, JREDA may or may not seek confirmations / clarifications and any offer(s) not in line with BID conditions shall be liable for rejection. Bidders are also requested to submit the documents / confirmations strictly as per the check list enclosed above. Any clarification/confirmation bidder may require shall be obtained from JREDA before submission of the bid.

#### 10.1.3 Part-III - PRICE

This cover should be sealed and superscripted "PART-III-PRICE BID" to be filled up exactly as per Format given in proforma-VII. This shall be filled up in both figures and words and signed on each page with stamp by authorised representative of the Bidder. Prices of each lot shall be mentioned in Words and Figures both. In case of any contradictions between the Prices mentioned in Figures and Words, the Prices mentioned in Words shall be considered Final. Also, in case of any arithmetical error in regard to the Total Amount and Individual rates, the Individual rates shall be taken as final and the total amount shall be adjusted accordingly. Price Offer should not contain any technical or commercial offer, likewise, technical or commercial offer should not contain price of any item, such cases, even if found any where, shall not be given cognizance of.

- 10.2 JREDA shall assume no responsibility for misplacement or pre-mature opening of any part of the bid, in case above instructions are not complied with by the bidder.
- 10.3 Any offer received after the deadline for submission of offers as specified above, shall be rejected and returned unopened to the bidder.





- 10.4 All the pages of bid documents, technical specifications, bids, supporting documents, etc. shall be duly signed by the authorised signatory and company seal should be affixed on each page. Any part of the bid, which is not specifically signed by the authorised signatory and not affixed with company seal, shall not be considered for the purpose of evaluation.
- 10.5 The offer should be signed and sealed by the bidder or his authorised representative. The names and designations of all persons signing shall be typed or printed below the signature.
- 10.6 The offer shall contain no erasures or overwriting except as necessary to correct errors made by bidder. Such corrections, if any, shall be initialed by the person signing the offer.
- 10.7 Failure to furnish all information and documentary evidence as stipulated in the bid document or submission of an offer that is not substantially responsive to the bid document in all respects shall be summarily rejected.

#### 11.0 EARNEST MONEY DEPOSIT (EMD)- To be submitted in Part-I

- 11.1 Bidder shall submit non-interest bearing Earnest Money Deposit (EMD) of Rs. 1,00,000/-(Rupees one Lakh only) for 500 CFL based SHLS in the form of Demand Draft from any Indian Nationalised Bank/ Scheduled Bank, drawn in favour of "Director, JREDA" payable at Ranchi or in the form of Bank Guarantee (enclosed at Proforma-X-A) from any Indian Nationalised Bank. The Earnest Money submitted in the form of Bank Guarantee shall remain valid for a minimum period of three months after the validity of the offer.
- 11.2 Bidder shall submit additional non-interest bearing EMD of Rs. 50,000 (Rupees Fifty Thousand only) for **each additional** 250 CFL based SHLS, if the bidder submits their offer for more than 500 SHLS.
- Earnest Money submitted in a separate sealed envelope (PART-I) duly superscripted with the Bid Enquiry reference, Bidder's own names full address and titled "Earnest Money".
- 11.4 Small Scale Industrial (SSI) Unit registered in Jharkhand shall submit non-interest bearing Earnest Money Deposit of Rs 50,000/- (Rupees Fifty Thousand only) for 500 SHLS in the form of Demand Draft from any Indian Nationalised Bank/ Scheduled Bank, drawn in favour of "Director, JREDA" payable at RANCHI or in the form of Bank Guarantee (enclosed at Proforma-X-A) from any Indian Nationalised Bank. Further SSI unit shall submit additional non-interest bearing EMD of Rs. 25,000/-(Rupees twenty fiveThousand only) for each additional 250 SHLS, if the SSI Unit submits their offer for more than 500 SHLSs.
  - ► For SSI units registered with Govt of Jharkhand as well as with NSIC: No earnest money is required to be deposited.

However, Bidders seeking concession/exemption from submission of Earnest Money, shall submit valid Registration Certificate in the envelope titled "Earnest Money" failing which the Bid will be treated as rejected. The request for adjustment of earlier dues in place of Earnest Money Deposit shall not be entertained.

Bidder those are not registered in Jharkhand as S.S.I unit shall submit EMD (as per clause no. 11.1 & 11.2) of exact amount in accordance to the quantity quoted failing which bid will be rejected.





The SSI units registered in State of Jharkhand must also furnish an attested photocopy of SSI unit certificate issued by Govt. of Jharkhand (GoJ) along with requisite earnest money as per Clause no 11.4 in this respect.

The SSI units registered in GoJ as well as with NSIC must furnish an attested photocopy of registration certificate issued by GoJ and NSIC clearly indicating the validity period.

- 11.5 Bidder who intends to submit offer for both CFL and LED based SHLS shall submit EMD as defined for CFL based SHLS. No additional EMD is required to be submitted for LED based SHLS.
- 11.6 The Earnest Money shall be returned to all the unsuccessful Bidders, within sixty days from the date of placement of LOI/Order to successful bidder.
- 11.7 In the event the Bid of any party is rejected during the course of Techno-Commercial Scrutiny and Evaluation, the Earnest Money will be returned to such Bidder.
- 11.8 Earnest Money shall be forfeited if
  - a) Any Bidder withdraws his Bid or resiles from his offer during the validity period.
  - b) The successful Bidder fails to furnish his Acceptance of the Order or fails to submit the Security Deposit within specified time as per terms of the LOI/Order.

#### 12.0 VALIDITY OF OFFER

The Bid and Price(s) quoted shall remain valid upto 120 days from the due date of submission of offer.

#### 13.0 OPENING AND EVALUATION OF OFFER

- 13.1 Part-I & Pat-II: EMD and Commercial & Technical Part will be opened on the date and time mentioned in the Table-I of NIB. at the office of Director, JREDA at Plot No. 328/B, Road No. 4, Ashok Nagar, Ranchi in the presence of bidders, or their authorised representative, who choose to attend the meeting. The representative should produce authorization letter to attend the bid opening meeting as given at Proforma-IV. The representative who does not produce such authorization will not be allowed to attend the bid opening.
- 13.2 If the EMD value submitted by the bidder does not match with the quantity offered, their offer is liable for rejection.
- 13.3 JREDA, if required, may at its discretion obtain clarifications on offers by requesting clarifications from any or all the bidders at any time prior to price bid opening (Part-III). Such request for clarification and the response shall be in writing.
- 13.4 JREDA shall examine whether bid is complete in all respect and conform to stipulated requirement of Technical specifications and Tests reports. The bid having material deviation shall be rejected as being non-responsive.
- 13.5 The Part–III: Price Part of each lot of only those bidders, whose offers are technically and commercially acceptable after evaluation of the Technical and Commercial Part, will be opened and evaluated. 13.6 The prices shall be evaluated separately for CFL based and LED based systems for the entire quantity quoted by the bidders for the complete scope defined in this document. Unit landed price (inclusive all taxes, duties, freight, insurance etc) for CFL based system will be evaluated and bidders shall be ranked. The bidder who has quoted the lowest evaluated rate shall be offered the quantity quoted. All the other bidders shall also be requested to match the lowest evaluated rate. For the bidders who matched the lowest evaluated rate, the balance quantity (if any) will be distributed amongst them.

Similarly for LED based system, unit landed price (inclusive all taxes, duties, freight, insurance etc) will be evaluated and the bidders will be ranked. The bidder who has quoted the lowest evaluated rate for LED based system shall be offered the quantity quoted. #### 14.0 CONTRACT PRICE

- 14.1 The total contract price & rates of SHLS in full and complete set including SPV module, control electronics, battery, mechanical components etc. should be quoted in **Proforma -VII** (Price Part). The price shall be inclusive of the total scope as defined in this document.
- 14.2 For Supply of items in full & good condition at FOR Site / Stores site (door delivery basis) to various consignees across State of Jharkhand, including transit insurance. Contract Price also includes all charges towards packing & forwarding, inspection Insurance and freight including door delivery charges. Contract Price is also inclusive of Excise Duty, CST and Sales Tax / Jharkhand VAT on the finished items, Turn Over Tax (TOT) / Octroi, Professional tax, entry tax etc. as applicable for the supplies.
- 14.3 Contract Price and unit rates shall remain firm and binding and shall not be subject to any variation, whatsoever, on any account except for statutory variation on taxes & duties during contractual completion period as stipulated in Clause no 14.4 below and / or addition or modification of scope of work.
- 14.4 Various taxes, levies and duties shall be paid against applicable documentary evidence limited to the maximum ceiling as indicated in the price schedule. **The bidder shall indicate various**





components of taxes and duties, freight, insurance etc that has been considered in the unit rates.

- 14.5 The Contract price & unit rates includes and covers the cost of all royalty & fees for all articles & processes, protected by letters, patent or otherwise incorporated in or used in connection with the work, also all royalties, rents and other payments in connection with obtaining all the materials for the work and the supplier shall indemnify and keep indemnified the JREDA, which indemnity, the supplier hereby gives against all actions, proceedings, claims, damages, costs and expenses arising from the incorporation in or use of work of any such articles, processes or supplies.
- 14.6 During the period of the contract, JREDA may order addition / deletion in quantities which supplier shall comply. The adjustment in Contract Price shall be made at the same unit rate as per Price Schedule.
- 14.7 All applicable charges for taking statutory clearances, wherever necessary, are included in the contract price.

#### 15.0 TERMS OF PAYMENT

#### A. The terms of Payment for Supply shall be as given below:

- a) Subject to deductions as per Clause 20.0, **95% of the contract price** shall be paid against delivery of goods in full and good condition on submission of following documents:

  - Copy of receipted Delivery Challan/ transportation Challan/ Lorry receipt.
  - Certificate of delivery of the system and delivery of user's instruction cum maintenance manual in terms of the Order, issued by Deputy Commissioner / Consignee's and JREDA representative.
  - Certificate of installation, testing and commissioning of SHLS in terms of the Order, issued by Deputy Commissioner / Consignee's and JREDA representative.
  - SHLS Serial No., Module Serial No. alongwith Test parameters and other materials supplied.
  - Certificate of training and awareness programme and testing of the SHLS in terms of the Order issued by Deputy Development Commissioner (DDC)/ Consignee's and JREDA representative.
- b) Balance 5% shall be paid after completion of Warranty period subject to deduction due to non-performance of the supplier during warranty period and submission of following documents:
  - Commercial Invoice in triplicate

    However, this 5% payment can be released after release of above 95% payment against a

    Bank Guarantee (BG) as per JREDA's proforma (enclosed at Proforma-X-C) from any
    Indian Nationalised Bank, valid till warranty period of SHLS. The proforma for BG is
    enclosed.
- c) All payments shall be released by JREDA within 30 days of submission of stipulated documents through account payee cheque issued in favour of the Supplier and payable at any Indian Nationalised/Scheduled Bank, Ranchi.





d) All the payment shall be paid in the name of only successful bidder not to anyone else.

#### 16.0 INCOME TAX

Without prejudice to the obligations of the Supplier under law, any Income Tax, which JREDA may be required to deduct by law/statute, shall be deducted at source and shall be paid to the Income Tax authorities on account of the Supplier. JREDA shall provide the Supplier a certificate for such deduction of tax.

#### 17.0 STATUTORY VARIATION IN TAXES AND DUTIES

- 17.1 The adjustment in the Contract Price towards imposition of new taxes or abrogation of existing taxes due to statutory variation shall be applicable only if the new tax is enacted or existing tax is abrogated within Contractual delivery/execution period. For any upward variation due to enactment of new tax or abrogation of existing tax after Contractual delivery / execution period, adjustment in the Contract Price shall not apply, although for any downward variation, JREDA shall make necessary adjustment in the rate of the items.
- 17.2 The Supplier shall bear and pay all liabilities in respect of statutory variations in taxes and duties and imposition of new taxes and duties that may be imposed after the Contractual delivery / execution dates, as originally stipulated, in case the delivery dates are extended due to reasons attributable to Supplier.
- 17.3 The adjustment in the Contract Price towards variation in the taxes shall be made by the JREDA on production of the documentary evidences by the Supplier and after completion of delivery.
- 17.4 The Contract Price shall be adjusted towards variations in taxes in respect of only finished equipment supplied by the Supplier to the JREDA. No adjustment in the Contract price shall be made for variations in the taxes on raw materials, parts, component / intermediate components, assemblies / sub-assemblies, etc.

#### 18.0 TRANSIT INSURANCE

Transit Insurance shall be arranged by the supplier for his total supplies.

In case of any damage / loss / pilferage / non-delivery during transit, the supplier shall lodge the claim and settle the claim with the insurance agency. The supplier shall also arrange replacement of the damaged, lost/pilfered items expeditiously pending settlement of commercial implications with insurance agency, if any, so as not to hamper the working of the system.

The resultant loss if any due to failure of supplier / sub- supplier to comply with the above shall be to the account of supplier.

#### 19.0 DESPATCH INSTRUCTIONS

- 19.1 All the items/Equipments shall be subjected to inspection by JREDA or authorised representative as per relative Standards/ provision approved by JREDA before dispatch of items.
- 19.2 The equipment shall be dispatched as per the detailed "Despatch Instructions" which will be required to be followed strictly at the time of despatch. However, equipment shall be dispatched only after receipt of "Despatch Clearance" from JREDA after inspection and acceptance of the





equipment is over. No consignment shall be dispatched without receipt of despatch clearance from JREDA.

#### 20.0 LIQUIDATED DAMAGES FOR DELAY IN COMPLETION

- 20.1 If the Supplier fails in the due performance of the Contract, to deliver and commission any part of the equipment or complete the work within the time fixed under the Contract or any extension thereof granted to him by JREDA and/or to fulfill his obligations in time under the Contract, he shall be liable to pay to the JREDA as pre-agreed liquidated damages a sum equipment to ½% of total contract value per week of such delay, or part thereof, subject to maximum of 5% of the total contract value.
- 20.2 The liquidated damages for delayed completion shall be recovered from the Supplier's bill or Security Deposit.

#### 21.0 DELIVERY

The delivery of goods at FOR destination in full as per the terms and conditions of the contract/order shall be completed within 3 (three) months from the earliest date of intimation of the order.

#### 22.0 INSPECTION OF THE FACTORY AND TESTS

- 22.1 JREDA reserves the right to inspect the manufacturer's works/factory to ascertain the capability/availability of necessary equipment & infrastructure required for manufacture of the item offered before opening of the price offers of the bidders.
- 22.2 JREDA shall have the right to inspect and test the goods to confirm their conformity to the technical specifications after delivery of goods to consignee.
- 22.3 Successful bidder shall inform JREDA at least 10 days in advance of schedule despatch.

#### 23.0 CANCELLATION OF BID / ORDER

The JREDA reserves the right to reject in part or full the awarded contract without assigning any reason of those firms which will be found defaulter for delayed supply or failure to deliver satisfactory performance or supply of substandard materials pursuant to clause 20.0 and 22.0.

The authority reserves the right to reject part or whole of the bid/order without assigning any reason thereof.

#### 24.0 WARRANTY PERIOD

The manufacturer must provide warranty for a minimum period of two years for the complete system including the battery and minimum ten years for PV modules from the date of commissioning the SHLS at site & demonstration of performance to the consignee/ JREDA. Supplier shall without prejudice to any other clauses of the order repair/replace the defective parts and restore the system to satisfactory working/performance within 7 days without any additional cost to JREDA within the period of Warranty.





### 25.0 TRAINING PROGRAMME, AFTER-SALES SERVICE AND AVAILABILITY OF SPARES

- 25.1 The responsibility of organizing training programme for SHLS will rest on the manufacturers/contractor. The training programme will be organized in consultation with JREDA/ Consignee. The training programme will focus on operation and maintenance of SHLS. Printed leaflet/literature should be made available in Hindi by the contractor regarding the operation and maintenance of their SHLS.
- 25.2 The supplier shall within 7 days from the date of the order depute authorised service engineer and establish sufficient inventory of spares in the state in consultation with JREDA to provide satisfactory and uninterrupted services during warranty period.

#### 26.0 PERFORMANCE GUARANTEE (SECURITY) DEPOSIT

The successful tenderer shall submit Performance Guarantee (Security) Deposit within 15 days from the date of Letter of award, in the form of Bank Guarantee from any Nationalized bank (as per Proforma–X-B) for a sum equivalent of 10% (Ten Percent) of contract price against and the valid till completion of supplies at site. The Performance Security shall be liable for forfeiture by JREDA in case of termination / cancellation of the order / contract pursuant to Clause 23.0 or failure of the equipment to deliver satisfactory and acceptable performance.

For SSI units registered with Jharkhand, this clause is not applicable.

For SSI units registered with Jharkhand as well as with NSIC, this clause is not applicable.

#### 27.0 AWARD OF CONTRACT/ORDER

The contract/order shall be awarded to techno-commercially acceptable and lowest evaluated bidder for the quantity quoted by the bidder

#### 28.0 AGREEMENT / CONTRACT

The suppliers have to enter into an agreement in the office of the Director, JREDA in prescribed format before commencement of supply.

#### 29.0 ARBITRATION

All disputes would be settled within Ranchi Juridiction of Court of Law only. All arbitration cases would only be settled under Arbitration and Conciliation Act 1996 but at Ranchi only.

#### 30.0 ASSIGNMENT

The supplier shall not assign, in whole or part, its obligations to perform under the order/contract, without written permission of the JREDA.

#### 31.0 FORCE MAJEURE

31.1 Notwithstanding the provisions of Clauses 20.0 and 26.0, the Supplier shall not be liable for forfeiture of its performance security, liquidated damages, or termination/ cancellation of





- order/contract if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- 31.2 For purposes of this clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the JREDA in its sovereign capacity, wars or revolutions, strikes and riots, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- 31.3 If a Force Majeure situation arises, the Supplier shall promptly notify the JREDA in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

### SECTION – 2A

### Technical Specification for CFL based SHLS

#### 1.0 **DEFINITION**

A Solar Home Lighting System (SHLS) aims at providing solar electricity for operating lights and/or fan or energizing a DC operated portable TV sets for specified hours of operation per day.

#### 2.0 SCOPE OF WORK

The scope of work for includes:

Manufacture/assemble, shop testing, packing & forwarding, transportation, transit insurance, supply, installation, testing & commissioning of CFL based SHLS system complete in all respects on turnkey basis along with one set of operation instruction cum maintenance manual (both English and Hindi) for each set and delivery on FOR destination/site (door delivery) basis across the State of Jharkhand including, demonstration of performance and training at all sites located within the state of Jharkhand as per direction of JREDA. List of villages will be given before start of dispatch by JREDA.

The solar home lighting shall be supplied as per the following specification.

#### 3.0 TECHNICAL SPECIFICATION

The CFL based solar home lighting shall be Indigenous make should conform to the following model:-

#### 3.1 DUTY CYCLE

#### 3.2 LAMPS

- (a) The lamps shall be compact fluorescent (CFL) type, 4 Pin, with rating of 9 W. A suitable pre-heating circuit must be provided.
- (b) The light output from the lamps should be around 600±5% lumens. No blackening or reduction in the lumen output by more than 10% should be observed after 1000 ON/OFF cycles (two minutes ON followed by four minutes OFF is one cycle).
- (c) The lamps should be housed in an assembly suitable for indoor use, with a reflector on its back. While fixing the assembly, the lamp should be held preferably in a base up configuration.

#### 3.3 BATTERY

- (a) The battery shall be of flooded electrolyte type, positive tubular plate, and maintenance free lead acid battery conforming to relevant BIS standards
- (b) The battery will have a minimum rating of 12V, 40Ah (at C/10) discharge rate
- (c) 75% of the rated capacity of the battery should be between fully charged and load cut off

#### 3.4 ELECTRONICS

- (a) The inverter will be of quasi sine wave/sine wave type with a frequency in the range of 20-35 KHz. Half-wave operation is not acceptable.
- (b) The total electronic efficiency shall be at least 80%
- (c) No blackening or reduction in the lumen output by more than 10% should be observed after 1000 ON/OFF cycles (two minutes ON followed by four minutes OFF is one cycle).
- (d) The idle current consumption should not be more than 10mA
- (e) Electronics shall be operate at 12 V and should have temperature compensation for proper charging of the battery through out the year.
- (f) Necessary length of wires/cables, switches suitable for DC use and fuses shall be provided.

#### 3.5 PV MODULE(S)

- (a) The PV Module(s) shall contain crystalline silicon solar cells.
- (b) The power output of the module(s) under STC should be a minimum of 37W.
- (c) The operating voltage corresponding to power output mentioned above should be 16.4V.
- (d) The open circuit voltage of the PV module under STC hall be at least 21.0V.
- (e) The terminal box on the module should have a provision for opening for replacing the cable, if required.





- (f) A strip containing the following details should be laminated inside the module so as to be clearly visible from the front side.
  - i. Name of the Manufacturer or distinctive logo.
  - ii. Model or Type No.
  - iii. Serial No.
  - iv. Year of make
- (g) Models of reputed make shall be offered.
- (h) Monogram of JREDA along with following details translated into Hindi language shall be embossed in Devnagari script on the left hand top corner of each PV module.
  - General Programme 2006- 07
  - Not for sale or transfer
  - Statutory action would be taken by JREDA, if it found sold or transferred.
  - Back side and frame of PV module shall be painted with colour as per direction of JREDA.

#### 3.6 ELECTRONIC PROTECTION

- (a) Adequate protection is to be incorporated under no load conditions (e.g. when the lamp is removed and the lantern is switched ON).
- (b) Battery cut offs & reconnects should be provided to protect it against overcharge and deep discharge condition.
- (c) A fuse should be provided to protect against short circuit conditions.
- (d) A blocking diode, diode, should be provided as part of the lantern electronics to prevent reverse flow of current through the PV module, if such a diode is not provided with the module itself.
- (e) Full protection against open circuit, accidental short circuit and reverse polarity should be provided.

#### 3.7 MECHANICAL COMPONENTS:

Metallic frame structure (with corrosion resistance paint) to be fixed on the roof of the house to hold the SPV module(s). The frame structure shall have provision to adjust its angle of inclination to the horizontal between 0 and 45, so that it can be installed at the specified tilt angle.

A vented metallic / plastic / wooden box with acid proof corrosion resistance paint for housing the storage battery indoors shall be provided.

- (iv) About CFL
- (v) About Battery
- (vi) Clear instructions about mounting of PV module(s)
- (vii) About electronics
- (viii) About charging and significance of indicators.
- (ix) Do's and Don'ts
- (x) Clear instructions on regular maintenance and trouble shooting of solar home system.
- (xi) Name and address of the person or service center to be contacted in case of failure or complaint.

#### 3.10 WARRANTY

The PV module will be warranted for a minimum period of 10 years from the date of supply and the solar home system (including the battery) will be warranted for a minimum period of two years from the date of supply. The warranty card to be supplied with the system must contain the detail of the system supplied as given in the Proforma VIII. The manufacturers can also provided additional information about the system and condition of warranty as necessary.

- 3.11 Any minor equipment and material which may not be specifically mentioned in this specification but are required to make the system complete in every respect in accordance with technical specification and guaranteed performance of the equipment shall be deemed to have been covered under the scope of this specification and shall be provided by the tenderer/supplier within the quoted price.
- 3.12 The Tenderer shall satisfy the purchaser that he possesses the necessary technical experience and has at his disposal suitable facilities and staff to ensure that the contract shall be executed with the best quality material and workmanship within the stipulated time. Necessary particulars in this regard shall be furnished with the Tender.
- 3.13 The equipment supplied shall be new and best of their kind and of latest technology on the date. All materials and equipment shall comply with the MNRE Standard.

Electronics Min 72% total efficiency.

Average duty cycle 4 hours a day

Autonomy Minimum of 3 days.

#### **Other Details**

#### 3.1 <u>DUTY CYCLE</u>

The LED solar street lighting system should be designed to operate from dusk to dawn, under average daily insulation of 5KWh/sq. m. on a horizontal surface.





#### 3.2 <u>LIGHT SOURCE</u>

- (i) The light source will be of white LED type. Single lamp or multiple laps can be used. Wider view angles preferred. The luminous performance of LEDs used should not be less than 30 lumen/watt. Use of LEDs, which emit ultraviolet light, should be avoided.
- (ii) The light output should remain constant with variations in the battery voltages.
- (iii) The lamps should be housed in an assembly suitable for outdoor use. While fixing the assembly the lamp should be held in a base up configuration.
- (iv) The make, model number, country of origin and technical characteristics of LEDs should be furnished to the test centers.

#### **3.3** PV MODULE

- (a) The PV module shall contain crystalline silicon solar cells.
- (b) The operating voltage corresponding to the power output mentioned above should be 16.4 V.
- (c) The open circuit voltage of the PV modules under STC should be at least 21.0 Volts.
- (d) The terminal box on the module should have a provision for opening for replacing the cable, if required.
- (e) A strip containing the following details
  - (i) Name of the Manufacturer or distinctive logo
  - (ii) Model or type number.
  - (iii) Serial no.
  - (iv) Year of make.
- (f) Models of reputed make shall be offered.
- (g) Monogram of JREDA along with following details translated into Hindi language shall be embossed in Devnagari script on the left hand top corner of each PV module.
  - General Programme 2006- 07
  - Not for sale or transfer
  - Statutory action would be taken by JREDA, if it found sold or transferred.
  - Back side and frame of PV module shall be painted with colour as per direction of JREDA.

#### **3.4** BATTERY

- (i) Flooded lead acid maintenance free battery. Battery should confirm to latest BIS standards or International standards. A copy of the test certificate should be provided to the test center.
- (ii) 75% of the rated capacity of the battery should be between fully charged & load cut of conditions.

#### 3.5 ELECTRONICS

- (i) The total electronic efficiency should be at least 72%.
- (ii) Electronics should operate at 12V and should have temperature compensation for proper charging of the battery through out the year.





- (iii) The light output should remain constant with variations in the battery voltages.
- (iv) Necessary length of wires /cables, switches suitable for DC use and fuses should be provided.

#### **3.6** ELECTRONIC PROTECTION

- (i) Adequate protection is to be incorporated under no load conditions, e.g. when the lamps are removed and the system is switched ON.
- (ii) The system should have protection against battery overcharged and deep discharge conditions. The numerical values of the cut off limits must be specified, while submitting he samples for the testing purposes.
- (iii) Fuses should be provided to protect against short circuit conditions.
- (iv) A blocking diode should be provided as part of the electronics, to prevent reverse flow of current through the PV module(s), incase such a diode is not provided with the PV module(s).
- (v) Full protection against open circuit, accidental short circuit and reverse polarity should be provided.

#### **3.7** MECHANICAL COMPONENTS

- (i) Metallic frame structure (with corrosion resistance paint) to be fixed on the top of the pole hold the SPV module. The frame structure should have provision to adjust its angle of inclination to the horizontal between 0 and 45, so that it can be installed at the specified tilt angle.
- (ii) It should be possible to mount the light source on metallic arm attached to the pole. The metallic arm for holding the light assembly will be extended at least 4 ft from the pole and set at a suitable tilt angle to provide uniform illumination over the specified area.

#### **3.9** DOCUMENTATION

An operation, instruction and Maintenance Manual, in English and the local languages should be provided with the solar home system.

- (a) About Photovoltaic
- (b) About LED solar home system its components and expected performances.
- (c) About PV module: Incase of imported modules it is mandatory to provide a copy of the international product qualification certificate to the test centre.
- (d) About LED lights: The make, modal number, country of origin and technical characteristics of LEDs should be stated in the product data sheet and furnished to the test centre.
- (e) About battery.
- (f) Clear instructions about mounting of PV module.
- (g) About electronics.
- (h) About charging and significance of indicators.
- (i) Do's and Don'ts
- (j) Clear instructions on regular maintenance and trouble shooting of solar home system.
- (k) Name and address of the person or service center to be contacted incase of failure or complaint.

#### **3.10** QUALITY AND WARRANTY

- (i) Components and parts used in LED solar home system should confirm to the latest BIS/ international specifications, wherever such specifications are available and applicable. A copy of the test report / certificate stating conformity of BIS/ international standards must be submitted to the test centre.
- (ii) The PV module will be warranted for a minimum period of 10 years from the date of supply and the LED solar home system including the battery, will be warranted for a period of at least 2 years from the date of supply.
