Minutes of Meeting of JREDA Tender Committee held on 02.09.2013 at JREDA Office for evaluation of Technical Bid against NIB No: 11/JREDA/SPV/SPP/NETARHAT/2013-14 for Design, Manufacture, Testing, Supply, Installation & Commissioning of indigenous Solar Photovoltaic Power Plants of Different Capacities including five years Comprehensive Maintenance Contract (CMC) on Turnkey basis in Netarhat School of Jharkhand.



Purchase Committee meeting of JREDA held on 02.09.2013 at JREDA Office for evaluation of Technical Bid against NIB No: 11/JREDA/SPV/SPP/NETARHAT/2013-14. Comparative Statement prepared by Tender Committee of JREDA and its recommendations were perused by Committee members.


On the basis of documents submitted by bidders and Comparative Statement of Technical Bid Part-I prepared by Tender Committee of JREDA views of Purchase Committee of JREDA on their Technical Bid are as follows:


1. **M/s Millennium Synergy Pvt. Ltd.:** The bidder is a manufacturer of Electronics and MSME of Jharkhand. The bidder has submitted average annual turnover of last three years ending 31.03.2013 of Rs. 2.98 Crore, Net worth as on 31.03.2013 of Rs. 1.44 Crore and cumulative experience along with successful completion certificates for more than 102.50 kWp of SPV Systems. The bidder in its certificate for annual turnover has submitted annual turnover of Rs. 2.98 Crore of M/s Millennium Synergy Pvt. Ltd, Ashok Nagar Ranchi. Further, on perusal of the balance sheets which are attached with this turnover certificate, it is observed that all the turnover figures are of M/s Millennium Synergy Pvt. Ltd., Bangalore. This indicates that the bidder has not submitted the copies of the balance sheets / documents of the applicant/ bidder firm i.e. M/s Millennium Synergy Pvt. Ltd., Ashok Nagar, Ranchi, which is an MSME unit of Jharkhand. Further, it has been observed that this bidder has not submitted the bid fee and earnest money on the pretext of being a MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and net worth as that of M/s Millennium Synergy Pvt. Ltd., Bangalore, which is not the bidder firm. Therefore, based on the documents submitted by the bidder it is recommended that the **bidder is not qualified for opening of Price Bid.**
2. **M/s Agni Power & Electronics Pvt. Ltd.:** The bidder is a manufacturer of Electronic component & Batteries and MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.16.00 Crore, Net worth as on 31.03.2012 of Rs. 5.79 Crore; and cumulative experience along with successful completion certificates for more than 700 kWp of SPV Systems. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
3. **M/s Sigma Steel & Engineers. Pvt. Ltd.:** The bidder is a manufacturer of Electronic component & Batteries. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.5.86 Crore, Net worth as on 31.03.2012 of Rs. 81.74 Lakh, and cumulative experience along with successful completion certificates for more than 200 kWp of SPV Systems. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
4. **M/s Statcon Power Controls Ltd.:** The bidder is a manufacturer of Electronics and MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.72.59 Crore, Net worth as on 31.03.2012 of Rs. 20.60 Crore, and cumulative experience along with successful completion certificates for more than 110 kWp of SPV Systems. The bidder has submitted cumulative experience along with successful completion certificates of order dated 17.02.2012 & its successful execution certificate dated 01.08.2012 of JREDA for 10 kWp and order dated 05.04.2013 & its successful execution certificate dated 28.06.2013 of WAA Solar Pvt. Ltd. for Airport Authority of India, Raja Bhoj Airport, Bhopal and same was sanctioned by MNRE to M/s Statcon Power Controls Ltd. for 100 kWp. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.





5. **M/s Luminous Power Technologies Pvt. Ltd.:** The bidder is a manufacturer of Electronics & PV System Integrator and MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2013 of Rs.1342.69 Crore, Net worth as on 31.03.2013 of Rs. 288.68 Crore, and cumulative experience along with successful completion certificates for more than 532.50 kWp of SPV Systems. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
6. **M/s Exicom Tele Systems Ltd.:** The bidder is a manufacturer of Electronics and MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2013 of Rs.60.85 Crore, Net worth as on 31.03.2013 of Rs. 56.36 Crore, and cumulative experience along with successful completion certificates for more than 460 kWp of SPV Systems. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
7. **M/s Rukmini Corporation:** The bidder has neither submitted Bid document Fee nor EMD, hence being a general bidder; **M/s Rukmini Corporation is not considered for opening of Price Bid.**
8. **M/s S.G. Enterprises:** The bidder is a manufacturer of Electronics, MSME of Jharkhand and MNRE Channel Partner. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.7.36 Crore, Net worth as on 31.03.2012 of Rs. 1.29 Crore, and cumulative experience along with successful completion certificates for more than 787.44 kWp of SPV Systems. Therefore, based on the documents submitted by the bidder it is recommended that the bidder is technically qualified for opening of Price Bid.
9. **M/s Solar Industries:** The bidder is a manufacturer of Electronics and MSME of Jharkhand. The bidder has submitted average annual turnover of last three years ending 31.03.2012 of Rs.83.93 Lakh, Net worth as on 31.03.2012 of Rs. 10.19 Lakh and Rs. 14.19 as provisionally calculated based on figures as on 31.03.2013(enclosed at C/61), cumulative experience along with successful completion certificates for more than 50 kWp of SPV Systems. However, he has submitted Credit Information Report/ Solvency Report of Union Bank of India dated 25.03.2013 for their credit limit of Rs. 32.00 Lakh Cash & Rs. 40.00 Lakh BG (enclosed at C/62) which may not be considered as per NIT terms & conditions. It was informed to the committee that in view of the request of bidder matter of consideration of Solvency Certificate in place of Net worth was placed and discussed in the JREDA Management Committee meeting held on 08.05.2013 but it was not accepted by the Management Committee. MSME bidder should have the minimum Net Worth of **19.05 Lakh** as on 31.03.2012/2013 on the basis of audited annual accounts but Net worth as on 31.03.2012 of M/s Solar Industries is only Rs. 10.19 Lakh. **Hence bidder is not qualified for opening of Price Bid.**




