Minutes of Meeting of Purchase Committee of JREDA held on 15.06.2013 at JREDA office for evaluation of Technical bid against NIB No. **02/JREDA/SPV/SL(CFL)/2013-14** for Manufacturing, Testing, & Supply of Indigenous CFL based Solar Lanterns under Solar Photovoltaic Programme for financial year 2012-13 for Jharkhand Renewable Energy Development Agency (JREDA).

Purchase committee meeting of JREDA held on 15.06.2013 at JREDA office for evaluation of Technical bid against NIT No. 02/JREDA/SPV/SL(CFL)/ 2013-14. Comparative Statement prepared by Tender Committee of JREDA and its recommendations were perused by the purchase committee members.

On the basis of documents submitted by bidders and the Comparative Statement of Technical bid Part-I prepared by Tender Committee of JREDA, the purchase committee has examined the document submitted by all the bidders and a statement has been prepared for all the bids and is enclosed. On the basis of it, the views of Purchase Committee of JREDA on their Technical evaluation are as follows:-

- 1. M/s Sunrise Technology, Gandhinagar, Gujarat: The bidder has quoted for 4500 Nos. Solar Lantern & submitted the equivalent amount of Bank guarantee for quoted quantity. Purchase committee observed that the bidder has submitted work order on page no. 98 to 249 but bidder has not submitted any performance certificate with respect to their work order. Therefore it is concluded the bidder does not have the required satisfactory work experience. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II)
- 2. M/s Su Solartech Pvt. Ltd., Chandigarh: The bidder has quoted for supply of 4500 Nos. Solar Lantern & submitted the equivalent amount of Bank guarantee for quoted quantity. Purchase committee observed that the bidder has submitted work order on page no. 27-28 but their Corresponding performance certificate has not been submitted. The bidder has submitted performance certificate issued from different department on page no. 29 for which work order has not been submitted. Therefore it is concluded the bidder does not have the required satisfactory work experience. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).

- 3. M/s Multi Services Inc, Jamshedpur:- M/s Multi Services Inc, Jamshedpur is a Jharkhand based MSME unit & manufacturer of Electronics items. The bidder has quoted for supply of 5000 Nos. Solar Lantern (CFL Based). The Purchase committee observed that the bidder has submitted the work orders which have been issued by the Private firms (77-89). Non of the experience certificate is from any SNA or Govt. body or PSU. Therefore it is concluded the bidder does not have the required satisfactory work experience from Govt. Department /PCU's for SPV systems. Hence it is recommended that the bidder is **not qualified** for the opening of Price Bid (Part-II).
- 4. **M/s Bhattacharya Engineering, Howrah**:- The bidder has quoted for supply of 4500 Nos. Solar Lantern (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 5. M/s Millenium Synergy Pvt. Ltd., Ranchi: The bidder has quoted for supply of 15000 Nos. Solar Lantern (CFL Based). The bidder in its certificate for annual turnover has submitted that the turnover certificate of Rs. 5.5 crore of M/s Millenium Synergy Pvt. Ltd., Ashok Nagar, Ranchi. Further on perusal of the balance sheet which are attached with this turnover certificate it is observed that all the turnover figure are of the Millenium Synergy Pvt. Ltd., Bangalore as submitted on page no. 35-129. This indicate that the bidder has not submitted the copy of the balance sheet / document of the applicant / bidder firm i.e. M/s Millenium Synergy Pvt. Ltd., Ashok Nagar, Ranchi which is a MSME unit of Jharkhand. Further it has been observed that this bidder has not submitted the BID fee and the earnest money on pretext of being MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and networth as that of M/s Millenium Synergy Pvt. Ltd. Bangalore which is not the bidder firm. Therefore Purchase committee recommended that the bidder is not qualified for the opening of Price Bid (Part-II) due to non submission documents related to its net worth & turnover requirement.
- 6. M/s NVIS Technologies Pvt. Ltd., Indore: The bidder has quoted for 4500 Nos. Solar Lantern & submitted the equivalent amount of Bank guarantee for quoted quantity. The bidder has submitted all work order of private firm on page 23-80. The bidder has also not submitted the IEC certificate of SPV Module. Purchase committee recommends that the bidder is not qualified for the opening of Price Bid (Part-II) due to their work experience & non submission of IEC certificate of SPV module.
- 7. M/s Pearl Enterprises, Pune: The bidder has quoted for 4500 Nos. Solar Lantern & submitted the equivalent amount of Bank guarantee for quoted quantity. All document submitted by the bidder as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).

- 8. M/s Solar Industries, Ranchi: The bidder has quoted for supply of 20000 Nos. Solar Lantern (CFL Based). As per the quoted quantity the networth should have been at least 28.86 lacs for MSME of Jharkhand but the networth of the M/s Solar Industries is 10.19 Lacs Only (53). All other documents submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for 7000 Nos. Solar Lantern and for the opening of Price Bid (Part-II).
- 9. **M/s Tata Power Solar System, Kolkata**: The bidder has quoted for supply of 45000 Nos. Solar Lantern (CFL Based). The bidder has submitted the work order on page no. 31 & the Corresponding performance for 3.75 kWp on page no. 32. The bidder has submitted work order on page no. 34-40 but their Corresponding performance certificate has not been submitted. The bidder has submitted performance certificate on page no. 39-53. But their Corresponding work order has not been submitted. Therefore it is concluded the bidder has failed to submit the desired documents to satisfy the requirements for required satisfactory work experience in this bid and it is concluded that bidder does not have the required satisfactory work experience. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).
- 10. M/s Vistar Electronics Pvt. Ltd., Pune: The bidder has quoted for supply of 4500 Nos. Solar Lantern (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. The bidder has submitted the CFL Lantern certificate issued by CPRI for test report dt. 02.01.2008 while the tender document has required the latest test report of the date not before that of 01.04.2009. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).
- 11 M/s Sigma Steel & Engineering Pvt. Ltd., Kolkata: The bidder has quoted for supply of 13500 Nos. Solar Lantern (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 12. M/s Sungrace Energy Solutions Pvt. Ltd., Ranchi :- The bidder has quoted for supply of 31500 Nos. Solar Lantern. The bidder in its certificate for annual turnover has submitted that the turnover certificate of Rs. 6.65 crore (52) of M/s Sungrace Energy Solutions Pvt. Ltd., Morabadi, Ranchi. Further on perusal of the balance sheet which are attached with this turnover certificate it is observed that all the turnover figure are of the Sungrace Synergy Pvt. Ltd., Hyderabad submitted on page no. 13-19. This indicate that the bidder has not submitted the copy of the balance sheet / document of the applicant / bidder firm i.e. M/s Sungrace Energy Solutions Pvt. Ltd., Ranchi which is a MSME unit of Jharkhand. Further it has been observed that this bidder has not submitted the BID fee and the earnest money on pretext of being MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and net worth as that of M/s Sungrace Energy Solution Pvt. Ltd, Hyderabad which is not the bidder firm. Therefore Purchase committee recommended that the bidder is not qualified for the opening of Price Bid (Part-II) due to non submitted its own net worth & turnover document.

- 13. M/s Kamla Instruments., Ranchi: The bidder has quoted for supply of 18000 Nos. Solar Lantern (CFL Based). All document submitted by the bidder are as per NIT. The bidder has submitted the net worth certificate of Rs. 21,11,661/- therefore it is concluded that the bidder is qualified for 14600 Nos. Solar Lantern on the basis of Net worth certificate. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 14. M/s Abhishek Industries, Ranchi: The bidder has quoted for supply of 45000 Nos. Solar Lantern (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 15. M/s Jain Irrigation, Jalgaon: The bidder has quoted for supply of 45000 Nos. Solar Lantern (CFL Based). The bidder is found eligible for 26000 Nos Solar Lantern on the basis of work order submitted on page no. 66-67, 68-71, 91, 102, & 105-109, and their corresponding performance certificate on page no. 65, 68, 110, 111, & 115. for a total capacity of 65.62 kWp. Therefore it is concluded that the bidder is qualified for 26000 Nos. Solar Lantern on the basis of satisfactory work experience. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 16. M/s U.M. Green Lighting Pvt. Ltd., Gurgaon, Haryana: The bidder has quoted for 45000 Nos. Solar Lantern & submitted the equivalent amount of Bank guarantee for quoted quantity. Purchase committee observed that the bidder has submitted balance sheet for two years on page no. 30-36. Further it has been observed that the bidder has submitted the Provisional Balance Sheet for FY 2012-13, as on page 38-39 instead of the audited balance sheet. The committee considered this point and observed that the copy of three balance sheet have been sought in the tender to substantiate the claim for being functional organization. Therefore on the basis of provisional balance sheet the functionality of the bidder may be accepted. Annual Turnover of this company is 715.76 crore on page no. 215 and Net worth is 170 Crore on page no. 218. Hence the committee recommends that the bidder is qualified for the opening of Price Bid (Part-II).
- 17. M/s Kali Son's Telvent Pvt. Ltd., New Delhi: The bidder has quoted for supply of 4500 Nos. Solar Lantern (CFL Based). The bidder is a MSME unit outside of Jharkhand but claiming the benefit of MSME Jharkhand. The bidder has not submitted Tender Fee, EMD Amount, Performance Certificate, IEC Certificate for Solar Module. The bidder has submitted work order on page no. 16-22 but has not submitted any performance certificate. The Net worth of bidder is 1.83 lacs only on page no. 25. Therefore it is concluded the bidder does not satisfy the tender conditions. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).
- 18. M/s S.G. Enterprises, Ranchi: The bidder has quoted for supply of 45000 Nos. Solar Lantern (CFL Based). The bidder has submitted performance certificate issued by JREDA on page no. 16-17 for which work order has not been submitted. Since the work order had been issued by JREDA itself and which are already available in the JREDA records, therefore on the basis of document as submitted by the bidder

the work experience of the firm can be accepted. Hence the committee recommends that the bidder is **qualified** for the opening of Price Bid (Part-II)

- 19. M/s Trinity Creations, Ranchi: The bidder has quoted for supply of 4500 Nos. Solar Lantern (CFL Based). All document submitted by the bidder are as per NIT. Hence the committee recommends that the bidder is qualified for the opening of Price Bid (Part-II).
- 20. M/s Plaza Power & Infrastructure Co., Himachal Pradesh:- The bidder has quoted for supply of 9000 Nos. Solar Lantern (CFL Based). The bidder has submitted balance sheet for two years only on page no. 50-59. The bidder has submitted work order on page no. 14-31 but bidder has not submitted any performance certificate with respect to their work order. Therefore it is concluded the bidder does not have the required satisfactory work experience. Hence it is recommended that the bidder is **not qualified** for the opening of Price Bid (Part-II).
