Minutes of Meeting of Purchase Committee of JREDA held on 20.06.2013 at JREDA office for evaluation of Technical bid against NIB No. **05/JREDA/SPV/SSL(CFL)/2013-14** for Manufacturing, Testing, & Supply of Indigenous CFL based Solar Street Lighting Systems under Solar Photovoltaic Programme for financial year 2012-13 for Jharkhand Renewable Energy Development Agency (JREDA).

Purchase committee meeting of JREDA held on 20.06.2013 at JREDA office for evaluation of Technical bid against NIT No. 05/JREDA/SPV/SSL(CFL)/ 2013-14. Comparative Statement prepared by Tender Committee of JREDA and its recommendations were perused by the purchase committee members.

On the basis of documents submitted by bidders and the Comparative Statement of Technical bid Part-I prepared by Tender Committee of JREDA, the purchase committee has examined the document submitted by all the bidders and a statement has been prepared for all the bids and is enclosed. On the basis of it, the views of Purchase Committee of JREDA on their Technical evaluation are as follows:-

- 1. M/s Su Solartech Pvt. Ltd., Chandigarh: The bidder has quoted for supply of 680 Nos. Solar Street Lighting Systems & submitted the equivalent amount of Bank guarantee for quoted quantity. Purchase committee observed that the bidder has submitted work order on page no. 32-38 but their Corresponding performance certificate has not been submitted. The bidder has submitted performance certificate issued from different department on page no. 31, 40 & 41 for which work order has not been submitted. Therefore it is concluded the bidder does not have the required satisfactory work experience. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).
- 2. M/s Millenium Synergy Pvt. Ltd., Ranchi: The bidder has quoted for supply of 3500 Nos. Solar Street Lighting Systems (CFL Based). The bidder in its certificate for annual turnover has submitted that the turnover certificate of Rs. 5.5 crore of M/s Millenium Synergy Pvt. Ltd., Ashok Nagar, Ranchi. Further on perusal of the balance sheet which are attached with this turnover certificate it is observed that all the turnover figure are of the Millenium Synergy Pvt. Ltd., Bangalore as submitted on page no. 71-133. This indicate that the bidder has not submitted the copy of the balance sheet / document of the applicant / bidder firm i.e. M/s Millenium Synergy Pvt. Ltd., Ashok Nagar, Ranchi which is a MSME unit of Jharkhand. Further it has been observed that this bidder has not submitted the BID fee and the earnest money on plea of being MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and networth as that of M/s Millenium Synergy Pvt. Ltd. Bangalore which is not the bidder firm. Therefore Purchase committee recommends that the bidder is not qualified for the

opening of Price Bid (Part-II) due to non submission documents related to its net worth & turnover requirement.

- 3. M/s Bhattacharya Engineering, Howrah: The bidder has quoted for supply of 2040 Nos. Solar Street Lighting Systems & submitted the equivalent amount of Bank guarantee for quoted quantity. All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II)
- 4. M/s Multi Services Inc, Jamshedpur:- M/s Multi Services Inc, Jamshedpur is a Jharkhand based MSME unit & manufacturer of Electronics items. The bidder has quoted for supply of 700 Nos. Solar Street Lighting Systems. The Purchase committee observed that the bidder has submitted the work orders which have been issued by the Private firms (Page No. 77-89). Non of the experience certificate is from any SNA or Govt. body or PSU. Therefore it is concluded the bidder does not have the required satisfactory work experience from Govt. Department /PCU's for SPV systems. Hence it is recommended that the bidder is not qualified for the opening of Price Bid (Part-II).
- 5. M/s Sigma Steel & Engineering Pvt. Ltd., Kolkata: The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 6. M/s Punam Energy Pvt. Ltd. Kolkata:- The bidder has quoted for supply of 100 Nos. Solar Street Lighting Systems (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. The Purchase committee observed that the bidder has submitted all work order for past experience issued from Private firms (page no. 47-54). Further the committee observed that the bidder has quoted for supply of 100 units against the minimum quantity of 680 units. Therefore it is concluded the bidder does not satisfy the tender conditions. Hence it is recommended that the bidder is **not qualified** for the opening of Price Bid (Part-II).
- 7. M/s Jain Irrigation, Jalgaon: The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- M/s Solar Industries, Ranchi :- The bidder has quoted for supply of 1360 Nos. Solar Street Lighting Systems (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).

- 9. **M/s Abhishek Industries, Ranchi**: The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is **qualified** for the opening of Price Bid (Part-II).
- 10. M/s Tata Power Solar System, Kolkata:- The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. The bidder has submitted work order on page no. 35-38 & 55-58 but their Corresponding performance certificate has not been submitted. The bidder has submitted performance certificate on page no. 33, 34, 39-54 But, their Corresponding work order has not been submitted. Therefore it is concluded the bidder has failed to submit the documents to satisfy the requirement for required satisfactory work experience in this bid. Hence it is recommended that the bidder is **not qualified** for the opening of Price Bid (Part-II).
- 11. M/s U.M. Green Lighting Pvt. Ltd., Gurgaon, Haryana :- The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based) & submitted the equivalent amount of Bank guarantee for quoted quantity. Purchase committee observed that the bidder has submitted balance sheet for two years on page no. 42-46. Further it has been observed that the bidder has submitted the Provisional Balance Sheet for FY 2012-13, as on page no. 47-55 instead of the audited balance sheet. The committee considered this point and observed that the copy of three balance sheet have been sought in the tender to substantiate the claim for being functional organization. Therefore on the basis of provisional balance sheet the functionality of the bidder may be accepted. Annual Turnover of this company is 715.76 crore on page no. 173 and Net worth is 170 Crore on page no. 175. Further the purchase committee took cognizance of the letter dt. 17.06.2013 of Sri Kedar Nath about this firm that this firm has submitted the forged document in year 2012 in JREDA tender and was debarred. In response to this the documents related to JREDA tender No. JREDA/RVEP/01/2011-12 dt. 16.12.2011 were also perused by the committee members which has the correspondence related to this matter. On perusal of this file it is observed that the then Director JREDA vide JREDA letter no. 17/2012-13 dt. 10.04.2012 had issued only warning to this firm and has not passed any other order debarring this firm. Therefore in such a background to take any further action at this stage will not be legally correct. Hence the committee recommends that the bidder is qualified for the opening of Price Bid (Part-II).
- 12. M/s S.G. Enterprises, Ranchi:- The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems (CFL Based). The bidder has submitted performance certificate issued by JREDA on page no. 16-17 for which work order has not been submitted. Since the work order had been issued by JREDA itself and which are already available in the JREDA records, therefore on the basis of document as submitted by the bidder the work experience of the firm can be accepted. Hence the committee recommends that the bidder is qualified for the opening of Price Bid (Part-II).

- 13. M/s Waaree, Energies Pvt. Ltd., Mumbai:- The bidder has quoted for supply of 1360 Nos. Solar Street Lighting Systems (CFL Based). All document submitted by the bidder are as per NIT. Hence it is recommended that the bidder is qualified for the opening of Price Bid (Part-II).
- 14. M/s Annapurna Export, Dhanbad: M/s Annapurna Export, Dhanbad is a Jharkhand based MSME unit. The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems. Purchase committee observed that the bidder has submitted work order on page no. 27-61 issued in favor of M/s Annapurna Export, Kolkata but their Corresponding performance certificate has not been submitted. The bidder has submitted performance certificate Page no. 26 issued in favor of M/s Annapurna Export, Kolkata instead of M/s Annapurna Export, Dhanbad, which is a bidder firm. Further on perusal of the balance sheet which are attached with the turnover certificate, it is observed that, all the turnover figure are of the M/s Annapurna Export, Kolkata instead of the bidder firm as submitted on page no. 17-22. This indicate that the bidder has not submitted the copy of the balance sheet / document related to turnover, networth and functionality of the applicant / bidder firm i.e. M/s Annapurna Export, Dhanbad., which is a MSME unit of Jharkhand. Further it has been observed that this bidder has not submitted the BID fee and the earnest money on the plea of being MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and networth as that of M/s Annapurna Export, Kolkata which is not the bidder firm. Therefore Purchase committee recommends that the bidder is not qualified for the opening of Price Bid (Part-II) due to non submission of its own networth, turnover document and experience documents.
- 15. M/s Sungrace Energy Solutions Pvt. Ltd., Ranchi :- The bidder has quoted for supply of 6800 Nos. Solar Street Lighting Systems. The bidder in its certificate for annual turnover has submitted that the turnover certificate of Rs. 6.65 crore (49) of M/s Sungrace Energy Solutions Pvt. Ltd., Morabadi, Ranchi. Further on perusal of the balance sheet which are attached with this turnover certificate it is observed that all the turnover figure are of the Sungrace Synergy Pvt. Ltd., Hyderabad submitted on page no. 13-19. This indicate that the bidder has not submitted the copy of the balance sheet / document of the applicant / bidder firm i.e. M/s Sungrace Energy Solutions Pvt. Ltd., Ranchi which is a MSME unit of Jharkhand. Further it has been observed that this bidder has not submitted the BID fee and the earnest money on pretext of being MSME unit of Jharkhand on one hand and on the other hand it has submitted the balance sheet in support of the criteria of turnover and net worth as that of M/s Sungrace Energy Solution Pvt. Ltd, Hyderabad which is not the bidder firm. Therefore Purchase committee recommends that the bidder is not qualified for the opening of Price Bid (Part-II) due to non submission of its own net worth & turnover documents.

16. M/s Kali Son's Telvent Pvt. Ltd., New Delhi: The bidder has quoted for supply of 680 Nos. Solar Street Lighting Systems (CFL Based). The bidder is a MSME unit outside of Jharkhand but claiming the benefit of MSME Jharkhand. The bidder has not submitted Tender Fee, EMD Amount, Performance Certificate, IEC Certificate for Solar Module. The bidder has submitted work order on page no. 16-22 but has not submitted any performance certificate. The Net worth of bidder is 1.83 lacs only on page no. 24. Therefore it is concluded the bidder does not satisfy the tender conditions. Hence it is recommended that the bidder is **not qualified** for the opening of Price Bid (Part-II).
